C. MEDICAL CARE & TRAVEL INSURANCE

We require that everyone coming from a non-EU country purchases medical and travel insurance for their stay in the UK. Please take out fully comprehensive travel insurance which includes such things as: medical costs (**minimum £1 million GBP or equivalent**), flights home due to emergency medical situations (including death and should also include evacuation cover), cancellation cover, personal belongings, legal and personal liability cover.

To ensure that you have adequate cover, we will check this on your arrival. If you cannot provide proof of your cover or it is inadequate for the UK and/or your outreach destination (as per the guidelines above), insurance will be purchased for you, **the cost of which will be added to your course fees.**

If you are a British or EU/EEA resident you can purchase Travel and Medical Insurance during the lecture phase ready for outreach.

LOCAL DOCTOR SURGERY / TREATMENT

Should you need to have an appointment with a doctor, whilst you are in the UK, you will be treated as a temporary resident. Please be aware that this may cost you at least £40 per visit (if you are a non-British).

D. FINANCES

The King's Lodge is run by a community of YWAMers who live by faith. No member of YWAM, either staff or trainees, receives a salary and each one has personal faith goals which they believe God to provide for every year. Your faith goal is your course fees. God's provision of your fees should be considered a seal of God's approval – an indication of His will for you to attend the course.

Your fees cover the cost of registration with the University of the Nations, tuition, board and lodging. Possible fee reductions are available to trainees from developing nations and to children of long term YWAM workers.

Should you be part of a course that has an outreach/field assignment, a separate fee will be charged, which will cover travel on the outreach, food and most other basic costs, but will not cover the cost of travel and medical insurance, any vaccinations or visas that may be required.

Before we can fully accept you for the course, you must either have all of your fees or know where the money is coming from (eg your church or family have pledged to provide for your fees, or you will be working before coming to the course and you know that your income will cover the fees). We will not be able to give you a full acceptance if this is not the case, unless your circumstances are exceptional. Please therefore communicate with us throughout the application process.

DTS FEES – FINANCIAL POLICY

1. REGISTRATION FEE: £25 (EU applicant)
£35 (non-EU applicant)

This is required to be paid before your application can be fully processed. This is non-refundable and covers the administration costs. The registration fee is in addition to the tuition fee.

2. DEPOSIT: £100

If your application is approved, we will send you a letter of acceptance. You will then need to send us the room deposit in order to secure your place in a room. This deposit is included in the total tuition fee and is non-refundable. **Please note, if you have money pledged towards your fees, we may ask that you pay part of your course fees prior to coming and before we issue you with a Visa Guarantee Letter / Certificate of Sponsorship.**

3. DTS COURSE FEES: **Jan & April 2012** **Sept 2012, Jan & April 2013**

Lecture phase fee: £1710 £1795*

*From September 2012, significant fee reductions for the lecture phase only are available for accepted applicants from developing nations. See our website for list of nations. (Category B Nations = lecture phase fee minus £500. Category C Nations = lecture phase fee minus £1000).

(**Outreach fees are approx and are dependant upon cost of airfares and based on recent outreach costs, does not include medical, vaccinations, visas, insurance)

PAYMENT OF FEES. ALL FEES ARE PAYABLE IN POUNDS STERLING ONLY.

Payment of the course fees may be made in the following ways:

- Bank draft, payable to "YWAM".
- Paypal/visa. This can be done through our website. There is a small charge for setting up a Paypal account. Paypal also deduct approx 4.8% in charges of any transaction made to "accounts@thekingslodge.com". **Please make allowances for their charges.**
- Cheque from a British Bank account – made payable to "YWAM".
- Debit or credit card – please call us if you wish to pay by this method. Charges will be applied for credit cards and overseas debit cards. For current charges, please contact: accounts@thekingslodge.com
- Cash for balance of fees on arrival – only in British Pounds Sterling.
(Your local bank will give you current exchange rates if you need them)

NB: We do not take cheques made out in foreign currency only in British Pounds Sterling, so we ask you to make payments in one of the above ways. Thank you.

WITHDRAWAL FROM THE COURSE / REFUND POLICY:

In the unlikely event of your withdrawing from the course, we will refund your fees on a percentage basis after the £100 deposit has been deducted:

RELEASE OF LIABILITY
